GENERAL INFORMATION AND RULES

Heritage Leadership wants everyone to have an enjoyable time. It is important to note that there are standards that are expected to be adhered to at all times by campers, leaders, and workers.

Attendance

Everyone is welcome to attend.

Group Leaders & Camp Workers

Group leaders, those who lead specific camp groups, must be saved, sanctified, and filled with the Holy Ghost.

Camp workers, those who assist with the operations of the camp, such as event setup, grounds upkeep, cooking and cleaning, must at a minimum be saved and sanctified or actively pursuing a sanctified lifestyle.

Whether a leader or worker, each individual should strive to live and maintain a lifestyle of Holiness.

Heritage Leadership will make final designations for group leaders and camp workers each camp year and reserve the right to modify or change those designations at any time. All group leaders and camp workers will be required to attend first aid and sexual harassment training at the beginning of each camp.

Clothing

All attire worn by leaders, workers, and campers must be modest.

Males must wear pants and a shirt with sleeves at all times while outside of their designated sleeping area. No tank tops, plain white t-shirts, or sleeveless muscle shirts. Pants may not fall below the waist.

Females must wear skirts or dresses below the knee and a shirt with sleeves at all times while outside of their designated sleeping area. No sleeveless shirts or tank tops.

Inappropriate Attire includes, but is not limited to:

- Attire that reveals the shoulders, such as spaghetti straps;
- Attire that reveals the upper body, such as mid-riff or belly shirts and backless/strapless tops;
- Attire that reveals the legs above the knee, such as skirts with splits exceeding the knee, or skirts that exceed the knee when sitting down without the use of a separate cover garment, such as a coat, blanket, etc.;
- Shorts;
- *For females:* Athletic skirts with leggings (attached or otherwise) exceeding the skirt length, and/or athletic skirts with splits exceeding the knee;
- Attire with obscene gestures or slogans;
- Jewelry; and,
- Makeup.

Heritage Leadership grants authority to group leaders and workers to enforce these requirements for campers and other attendees. Anyone in violation of these requirements will be asked to change into appropriate attire.

Heritage Leadership reserves the right to modify these requirements at any time with or without notice.

Items All Attendees Must Bring to Camp

- **Bedding:** Pillow, blanket, and/or sleeping bag;
- **Clothes (Males):** Pants/jeans, belt, shirts, underclothes, socks, shoes, flip-flops (if desired), church attire (casual or dress);
- **Clothes (Females):** Skirts/dresses, shirts, underclothes, socks, shoes, flip-flops (if desired), church attire (casual or dress);
- **Toiletries:** Soap, body wash, shampoo, towel, washcloth, personal hygiene wipes, deodorant, comb, brush, toothpaste, etc.;

- **Other Items:** Bible, laundry bag, flashlight, medication(s), sunscreen, insect repellent.

Items NOT PERMITTED:

- Tobacco, alcohol, or narcotics;
- Cell phones by campers (cell phones will be collected at camp registration, stored in a secure area, and returned at camp departure);
- Radios, CD players, or digital music players;
- Secular advertisement, such as suggestive wording, pictures, sports teams and players, music groups, cigarette or alcohol advertisements, etc..

Camp Schedule

A camp schedule will be created by Heritage Leadership prior to each camp and will be available for review and distribution by all group leaders, camp workers, campers, and attendees.

Other Pertinent Rules

- All group leaders, camp workers, campers, and other attendees, must attend all worship services;
- Group leaders and campers must attend all activities involving the camp schedule;
- No adult and minor who are not immediate family may be alone at any time for any reason, except in the event of a crisis or emergency;
- No public displays of affection, such as hugging, kissing. Exception: Parents visiting their children;
- Two-feet of distance must be maintained by all male and female campers at all times.
- Group leaders, camp workers, campers, and other attendees may not pair off into dark or secluded places;
- Any other rules deemed necessary by Heritage Leadership must be followed.

First Aid and Emergency Medical Treatment

There may be occasions where a group leader, camp worker, camper, or other attendee, may be in need of first aid or emergency medical treatment as a result of an accident, illness, or other health condition or injury.

By acknowledging the receipt and review of this document, all individuals give permission to Heritage Youth Camp and its authorized representatives to seek and secure any needed medical treatment. Individuals further give permission to physician(s) and other medical personnel to administer any needed medical treatment, such as x-rays, injections, anesthesia, hospitalization, I-Vs, blood transfusions, medications, and surgery if deemed medically necessary.

By acknowledging the receipt and review of this document, all individuals agree that Heritage Youth Camp and its authorized representatives are not responsible for fees or costs arising from the action to obtain medical treatment.

Administration of Medication

There may be occasions where a camper or other attendee may be unable to administer medication themselves. With written permission from a parent or legal guardian, Heritage Youth Camp and its authorized representatives, including group leaders and camp workers, may administer medication. Medication will be administered according to the healthcare provider's prescription and/or the manufacturer's instructions.

By acknowledging the receipt and review of this document, all individuals agree to hold harmless Heritage Youth Camp and its authorized representatives for the proper administration of medication.

Removal from Camp

Group leaders, camp workers, campers, and other attendees must abide by the information contained with this document. Failure to do so may result in removal from the camp.
